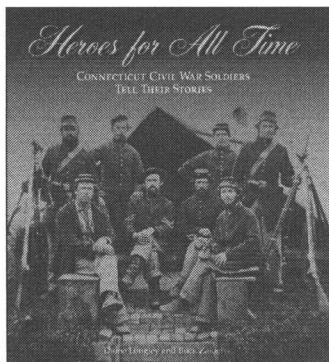

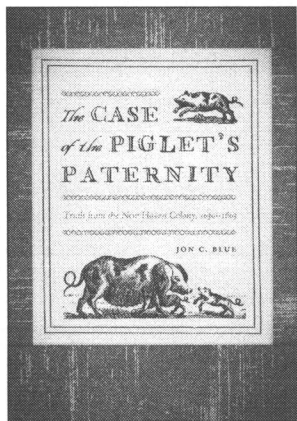

Submission to *Connecticut History Review*

Connecticut History Review, a continuation of *Connecticut History*, is a publication of the Association for the Study of Connecticut History, and appears twice annually, in the spring and fall. The journal is published in cooperation with Fairfield University and receives financial support from Fairfield University.

Connecticut History Review aims to bridge the history "gap" among academia, public history institutions, secondary-school educators, and history buffs. Each issue contains original articles, exhibition reviews, book reviews, web-site reviews, and research notes on the history and culture of Connecticut. Articles appearing in the journal are indexed in the databases "America: History and Life" and "Academic Search Premier," as well as in *The Journal of American History*.

The journal seeks original research articles on a wide variety of topics, spanning all aspects of Connecticut's history. There is no set word length on articles, though the average length is 12,000-15,000 words. Black&White photographs and illustrations are welcome.

The journal is also interested in essays on special programs or holdings of historical societies and museums, as well as articles on history pedagogy and educational programs at both the collegiate and secondary level. Historical societies and museums that would like to have exhibitions reviewed or listed should contact the Editor-in-Chief.

In addition, the journal seeks papers, curriculum units, and museum or historical society exhibitions that discuss, teach, or present Connecticut history through the larger story of American history.

All authors desiring to submit original articles for publication consideration in *Connecticut History* may send an electronic copy of the proposed article (in .doc or .docx format) to the editor-in-chief. The author's name should not appear on the submission itself. All articles and other submissions should conform to the Chicago Manual of Style, utilizing footnotes. Please provide both email and regular mail addresses so that the editor may contact you regarding the receipt and possible acceptance of the proposed article. Articles and essays submitted to *Connecticut History Review* should not be submitted to any other publication while under consideration.
