

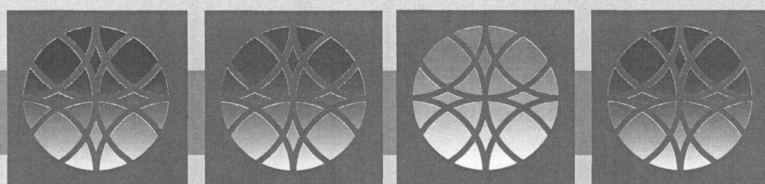

APQ is published by the University of Illinois Press on behalf of North American Philosophical Publications.

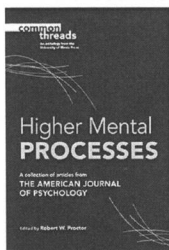

MANUSCRIPTS

Contributions may be as short as 3,000 words or as long as 8,500. All manuscripts should be typewritten with wide margins, and at least double spacing between lines. Authors should follow *Chicago Manual of Style* (16th edition) in preparing their manuscripts. Endnotes should be used sparingly and should be numbered consecutively, typed with wide margins and double spacing, and placed at the end of the paper. Submissions should be sent as a Microsoft Word or rich text file in an e-mail attachment to hpq@bu.edu. The journal will consider only papers whose authors certify that, while under consideration with us, their papers will not be submitted elsewhere for consideration.
