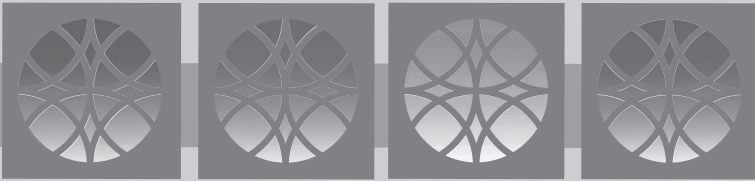

APQ is published by the University of Illinois Press on behalf of North American Philosophical Publications.

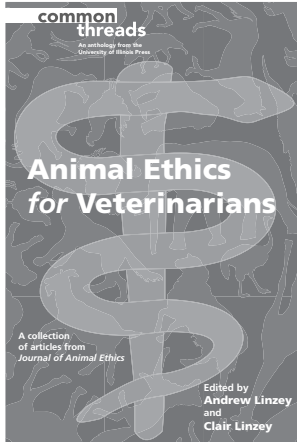

*Animal Ethics
for Veterinarians*

This Common Threads volume, drawn from articles originally published in the *Journal of Animal Ethics* (JAE), offers veterinarians and other interested readers a primer on key issues in the field. Essays in the first section discuss aspects of veterinary oaths, how advances in animal cognition science factor into current ethical debates, and the rise of complementary and alternative veterinary medicine and its relationship to traditional veterinary medicine. The second section continues with an essay that addresses why veterinarians have an obligation to educate animal caregivers to look past “cuteness” in order to treat all animals with dignity. The collection closes with three short sections focusing on animals in farming, trade, and research—areas where veterinarians encounter conflicts between their job and their duty to advocate and care for animals.

MANUSCRIPTS

Contributions may be as short as 3,000 words or as long as 8,500. All manuscripts should be typewritten with wide margins, and at least double spacing between lines. Authors should follow *Chicago Manual of Style* (17th edition) in preparing their manuscripts. Endnotes should be used sparingly and should be numbered consecutively, typed with wide margins and double spacing, and placed at the end of the paper. Submissions should be sent as a Microsoft Word or rich text file in an e-mail attachment to hpq@bu.edu. The journal will consider only papers whose authors certify that, while under consideration with us, their papers will not be submitted elsewhere for consideration.
