### POLISH AMERICAN STUDIES EDITORIAL INFORMATION

Contributions and correspondence dealing with editorial matters should be sent via email attachment to Anna D. Jaroszyńska-Kirchmann, Editor, at [kirchmanna@easternct.edu](mailto:kirchmanna@easternct.edu). The editors welcome scholarship including articles, edited documents, reviews and related materials, dealing with all aspects of the history and culture of Poles in the Western Hemisphere. They particularly welcome contributions that place the Polish experience in historical and comparative perspective as part of the larger Polish diaspora, and by examining its relationship to other ethnic groups. Contributions from any discipline in the humanities and social sciences are welcome. The journal employs a "double-blind" review process. Manuscripts are evaluated based on their originality; relevance to the mission of the journal; the clarity of the thesis, presentation and conclusions; and the depth of research based upon the nature of the sources cited. The editors will *not* review work previously published in any form or ghost-written works. Contributions should follow *The Chicago Manual of Style*, 17th Edition. Contributors whose first language is not English should have their work reviewed for clarity and grammar prior to submitting it for consideration. Manuscripts should be no longer than 8,000 to 10,000 words plus notes, tables, etc. They should include an abstract of about 200 words, and a brief author's biographical information, their affiliation, and email address. It is the author's responsibility to obtain all copyright permissions for illustrations and images. Published articles become the property of the Polish American Historical Association. The editors of *Polish American Studies* and the Polish American Historical Association accept no responsibility for statements of fact or of opinion made by the contributors.

Books for review (English language) should be sent to Mary Patrice Erdmans (Department of Sociology, 10900 Euclid Avenue, Case Western Reserve University, Cleveland, OH 44106) or Anna Mazurkiewicz (Polish language; University of Gdańsk, Faculty of History, ul.
