



Submission Guidelines for PROCESS STUDIES

Format of Articles: Authors who submit manuscripts should consult first the most recent issue of the journal to familiarize themselves with the journal's formatting system. Articles normally should be 4,000–8,000 words and typed with double spacing in 12 pitch. Include a title page containing the author's current mailing address, email address, phone and fax numbers, and a short biographical statement (2–3 lines). The manuscript should include (on every page, top right) an abbreviation of the title but *not* the author's name, since the assessment is "double-blind" (anonymous to author and assessors).

References to Whitehead's and Hartshorne's Works: *Process Studies* abbreviates Whitehead's and Hartshorne's works as acronyms (listed on the inside back cover of the journal). Publications—books or articles—other than Whitehead's and Hartshorne's are cited also as acronyms (using journal titles rather than article titles, and book titles rather than chapter titles), with full bibliographical information listed at the end of the article in the "References" section. Also, please note the following: (1) some references cited should list full bibliographical information only in the notes, not in the References section, i.e., (a) references which are cited in the text of the article only minimally, and/or (b) those which are not central to the main arguments of the article, and (c) those which are cited only within the notes and not in the main text of the article; (2) if such references are cited more than once within the notes, the second and following references should use acronyms. (Please note also that the journal avoids the use of "p" and "pp" for page references, and avoids "ibid" and "op cit.")

Notes: Manuscripts should be formatted using *endnotes*, not footnotes. The notes should be listed on a separate page at the end of the article. This is a change back to our former policy after a brief experiment with footnotes. Please note that the endnotes normally should be limited in number and restricted to substantive information.

Mailing: The original and three (3) copies of the manuscript should be sent to Dr. Barry Whitney, Editor, *Process Studies*, University of Windsor, PO Box 33830, Detroit, MI 48232 USA. The most efficient means of mailing from within the USA is not a private courier but the USA-Postal Service's \$3.00 2-day express envelope. A computer disk should be sent to the editor only *after* the article has been accepted for publication. While future issues will be formatted with Page-Maker software, we prefer disks formatted in PC format and "Word Perfect 8 for Windows" word processing program.

These abbreviations (acronyms) are introduced parenthetically in the text, followed only by page numbers. Abbreviations (acronyms) are used for other books and articles cited in the text: see **Submission Guidelines**. Bibliographical information for Whitehead's and Hartshorne's texts need not be listed in the **References** section at the end of the article. Other references cited, however, should list full **bibliographical information in the References section**. References cited only in footnotes should list the bibliographical information only in the footnotes (again, see Submission Guidelines). Contributors are requested to refer to the editions listed above and to follow this style in manuscript preparation.

*Beginning with *Process Studies* 8/3 (1978), we cite PR first according to the Corrected Edition, then according to the Macmillan 1929 edition. However, beginning with *Process Studies* 20/1 (1991), all citations of Whitehead's works are made to the Free Press (or other recent) editions whenever possible, and not to the original editions.
